Also available this year at the annual meeting will be a calendar created by Tribal staff which will include the rest of this calendar year and calendar year 2009. Following the annual meeting, the calendar will mailed out to each tribal household.

No election will be held this year, as only the incumbents have filed for candidacy. These incumbents are: Doyle Barry Kerr (Vice Chairman), Shirley Staubus (Secretary), Scott Secondine, and Benjamin Barnes (Business Committee members). Children's and Family Services Department

Several programs operate within this department and staff have been very busy with many different activities through out the summer. In July, staff helped conduct the annual Safety Camp provided in conjunction with the other area local Tribes. Trips to the Wildcat Glades Conservation and Audubon Center in Joplin, MO and Silver Dollar City in Branson, MO were attended by almost 100 tribal children. The Department along with the Peoria Tribal CCDF program hosted the 3rd annual Children's Pow Wow on June 14th. Over 200 people



were in attendance and activities included appearances by the Kickapoo Nation School Youth Drum Club, and All Nations Youth Dance Group from Tulsa, OK. Other activities included Gourd Dancing, a dinner was served to all participants and guests, and inflatable activity centers for the children. The Wyandotte Color Guard presented the colors.

On August 5- 7th, staff conducted the annual school supply give away to all Tribal children grades Pre-K through 8th grade within a 100 mile

radius from Miami, OK. Over 120 backpacks were given out to Tribal children . At this year's give away, a mobile unit hosted by the Miami area Lions Club provided hearing and vision tests to children participating in the school supply give away. Also offered was the Children's ID Disk program that we have had available at past children's events. The Department is still exchanging old mercury thermometers for new temporal scan digital thermometers at our Social Service Building in Miami, OK. To date, staff has received 48 old mercury thermometers and given out 39 new digital thermometers. Please bring your old mercury thermometers double bagged in a zip lock sandwich bag to the annual meeting to participate in the exchange program.

Our annual meeting is scheduled for September 20th. Reports will be given on all programs and services. Financial responsibility is extremely important to me and your elected business committee members. Not only do we have our own independent auditors, but we recently completed a mandatory Bureau of Indian Affairs audit. These complimentary reports are available for your review. Your tribe is financially sound.

We are in the final days of construction on our new community building. Per the guidelines of our application, this building is to be used primarily as a well-

ness center. We have taken this wellness program one step further. As most of you know, diabetes is a major concern for many of our tribal members. The working condition for the diabetes staff at the Indian Health Center is very inadequate. After discussions with our Shawnee business committee and the directory of the Indian Health Center, we have all agreed we can create a first class facility in our new building. It will be used daily, not only by our Tribal members but by all Tribes with needs. While this may cause some minor inconvenience should we wish to have a tribal function, the trade off is worth it for the

positive impact we can have on peoples lives. Let's keep that in mind. By doing this, we are also in compliance with our grant request.

Since last spring, Rebecca Hawkins resigned as our Tribal Administrator. The assistant, Jodi Hayes, has been elevated to Administrator by the employment committee. Jodi is well qualified and is doing a tremendous job. I want to thank Rebecca for her many years of outstanding contributions to the Tribe and wish her well in her future endeavors.
